STATE OPIOID RESPONSE (SOR) REQUEST FOR PROPOSALS

FREDERICK, MD -- The Maryland Department of Health, Behavioral Health Administration (BHA) was recently awarded a two year "State Opioid Response (SOR)" grant from the Substance Abuse and Mental Health Services Administration (SAMHSA). This award is to support the ongoing statewide efforts to combat the opioid epidemic. The SOR grant is designed to address Maryland's opioid crisis by increasing access to evidence-based treatment, reducing unmet treatment needs, and reducing opioid related deaths through the provision of prevention, treatment, and recovery support services.

Dedicated statewide funding has been identified to expand recovery housing for young adults with an Opioid Use Disorder (18-25 years of age) in the amount of \$298,395, and for adults and older adults with an Opioid Use Disorder (over 26 years of age) in the amount of \$1,536,199. The goal is to expand the number of credentialed recovery houses to support 160 adults and 8-12 young adults. The grant period is September 30, 2018 through
