1. Introductions

Jay Hessler convened the meeting and introductions of meeting attendees occurred.

2. Review/Approval of Minutes

Minutes were reviewed and no corrections were noted.

3. Announcements

- a. The Veterans Subcommittee will continue to maintain their current subcommittee meeting time, the second Monday of every month and will not be meeting during the Suicide Prevention Coalition meeting time. The subcommittee will provide a report out at each Coalition meeting and a report out of the other subcommittees will also be provided to the Veterans subcommittee.
- b. The Frederick County Health Department/LBHA submitted an application for grant funding for a public service announcement for suicide prevention through the Maryland Behavioral Health Administration. There was a short turnaround for applications and only LBHA were able to apply for this funding. If funds are granted, the PSA would be created in collaboration with Channel Communications and the Education/Outreach subcommittee; as well as, any other members from the coalition who wanted to participate. Updates/information will be shared regarding the status of the application.

- c. During the March Coalition meeting, Janel Cubbage from the Johns Hopkins Center for Gun Violence Solutions will be coming to speak regarding ERPO.
 - d. The Suicide Prevention Coalition meetings will be extended to 1.5 hours to allow time for subcommittees to meet.
 - e. The previous invite for the Suicide Prevention Coalition Meeting (1-2pm) will be cancelled.
 - f. There is no update on the Suicide Prevention website. The website is still in creation, as the County is revamping the entire county website.
 - g. The Behavioral Health Administration will begin providing announcements/information at each meeting beginning at the February Coalition meeting.

 - 1. Public outreach for responsible gun ownership
 - 2. Solutions for safely storing firearms within the county

 - 4. Gun requirements that need to be changed
 - 5. Education for law enforcement regarding filling out EP
 - ii. Interested in inviting entities from DNR and firearm retail owner to participate in subcommittee to include perspective from those areas

 - i. Will review at logic model items more in depth but agree the items align with the subcommittee goals

 - 1. Low-cost/no cost trainings for best practices and suicide risk screenings
 - 2. Identifying and promoting social media campaigns to support suicide prevention
 - 3. Creating effective suicide prevention outreach
 - c. Postvention – Leadership: Kaili Van Waveren with assistance from Amanda Adams
 - i. Logic model items were reviewed and agreed to align with subcommittee goals
 - ii. Areas/items interested in addressing:

1. Raising awareness of Postvention/support services to include helping professionals (compassion fatigue/vicarious trauma)
2. Reviewing current Postvention plans, to help create effective Postvention protocols around the County
3. Will begin identifying and working on landscape analysis of transition and recovery services, to include FHH, Brook Lane, Sheppard Pratt Mobile Crisis and MHA
