Frederick County Board of Health

- Maryland law establishes a Board of Health in each county.
- The local Board may adopt and enforce rules and regulations on any nuisance or cause of disease in the county as long as these are not contrary to and are at least as stringent as existing State laws, rules and regulations.
- The membership of the Board of Health consists of the seven County Council members and the County Executive
- The County Health Officer is the executive officer and secretary of the Board of Health.
- Meetings are required in May and October. Additional meetings can be added as needed.
- *soon Liaison to the Board positions will be added

Overview of Health Department



History of Public Health in Frederick County

In 1886, there was an ongoing epidemic of diphtheria in Frederick city.

The new health officer set out to improve the sanitary conditions and made recommendations to stop the spread of this disease in canneries, slaughter shops, compost heaps, hog pens, cesspools and privies, tanneries, streets and alleys, gutters and sewers along Carroll Creek.

DIPHTHERIA IN FREDERICK CITY.

From August, 1881, Frederick had been experiencing an excessive mortality from diphtheria. This disease was destroying on an average fifty children per annum, or 3 1-2 per cent. of the population of the city under ten years of age; and while there was great dissatisfaction at this state of affairs, and several spasmodic efforts had been instituted to detect the cause and arrest the further progress of this scourge, nothing of any practical value had been done.

During the first few weeks after my appointment, numerous verbal complaints were heard by me from the citizens of Frederick and its vicinity, and on August 25th the following letter was received, which is here given in full because it presents the prevailing sentiment of the community at that time, and because from this date was initiated your efficient action in seeking out the causes of that dreadful plague and inaugurating with the efficient aid of the City Health Department the measures which have effectually stamped it out.

LETTER FROM HON. MILTON G. URNER.

Frederick, August 25th, 1886.







In the third image, all three can see the game without any supports or accommodations because the cause of the inequity was addressed. The systemic barrier has been removed.










Geographic Disparities




Disparities

Youth Risk Behavior Survey (YRBS)

The Maryland YRBS is a CDC-sponsored survey of students in Maryland public **middle and high schools**, focusing on **behaviors that contribute to the leading causes of death and disability**, including but not limited to, alcohol and other drug use, tobacco use, sexual behaviors, unintentional injuries and violence, and poor physical activity and dietary behaviors.





By the Numbers: 2021-22 Frederick County YRBS

- Survey Administration from Sept. 27, 2021 – January 28, 2022 (state range)
- 11 Frederick County middle and 10 high schools surveyed
- 4,495 Frederick County students completed surveys
 - 1,282 middle school students
 - 3,213 high school students
- Over % overall response rate
 - 85% middle school students
 - 84% high school students




Overall Trends from the 2021-2022 YRBS


- Despite the return to in-person learning environments, Maryland's students are undoubtedly **still feeling the effects of the pandemic** which have contributed to the **poor mental health outcomes** found on the most recent YRBS.
 - **Female students and students identifying as LGBTQ+** were significantly **more likely** to report these mental health issues.
- Changes in youth lives related to virtual learning and social isolation may have contributed to the **rapid decline of most substance misuse** including tobacco, alcohol, marijuana, and other illicit substances.

- Mental health was most of the time or always not good 30 days before survey
- Felt sad or hopeless almost every day for 2 weeks, stopped usual activities





Substance Use in Last 30 Days





2018: High School 17.6%






Substance Use – Cannabis Use

With the upcoming legalization of adult cannabis possession and use in July, the baseline for current cannabis use among high school students is important to know.

- 2.9% of middle school students reported past 30 day use of cannabis. **2018: 3.4%**
- 13.6% of high school students reported past 30 day use of cannabis. **2018: 19.6%**












Students with Multiple ACEs – Frederick County









PCEs and Risk Behaviors (Students with 1 or more ACE) - Frederick County HS (2)




Disparities Among LGBT Students

- Sexual orientation and gender identity questions were asked on the high school YRBS survey.
- According to the 2021 Maryland Youth Risk Behavior Survey (YRBS), **26%** of Frederick County students sexually identified as **other than Heterosexual**.
 - Prevalence is two and a half times higher than in 2013 (10%), the first year of this report.
- The most frequently selected identity was **Bisexual (11%)**, while **4%** identified as **Gay or Lesbian**. The remaining students described themselves as **Other (5%)**, **Questioning (4%)**, and **Not Sure (2%)**.
- Among all students, **3.4%** identified as **Transgender**.
 - Of all Lesbian, Gay, and Bisexual (LGB) students, 11% identified as Transgender. Within Other/Questioning students, 18% identified as Transgender.
- **Overall, LGBT students continue to have more personal challenges and risk behaviors compared to their Heterosexual counterparts in areas such as mental health issues, physical health concerns, weaker parental ties, bullying, sexually activity, and substance use.**



Final Thoughts

- Increases in poor mental health outcomes call for **improved access to mental health support in school and at home** and **increasing positive childhood experiences** through peer supports, school-based extracurricular activities, and adult support.
- As students return to school, we hope that there are programs in place to **educate and re-emphasize the harms of substance use**.
- The next YRBS data set (2022-2023) will be released early 2024 and will include the full 8 question ACEs module on the high school survey.
- The next YRBS administration is scheduled for Fall 2024.

An Act To Establish a Board of Health

- Frederick County Council passed legislation April 18, 2023 to establish a Board of Health and the County Executive signed it April 25 for an effective date of June 17, 2023.
- Under Md. Code Ann., Health-Gen. § 3-201(b), the county's "governing body" [Council + Executive] was its ex officio board of health, unless and until the county established a board of health. Under Health-Gen. § 3-306(c) the health officer is the executive officer and secretary of the county board of health.

Board of Health Powers and Duties

Chapter 1-2: Administration
Article XVIII. Board of Health

1. Have the powers and duties granted to a local board of health under State law including those provided in Title 3 of the Health-General Article of the Annotated Code of Maryland.
2. Assist and cooperate with the Secretary of the Maryland Department of Health in health-related matters, including behavioral health.
3. Have general responsibility for the health and sanitary interest of the people of the County including the investigation and study of the causes of disease, epidemics and nuisances affecting public health, behavioral health, the prevention of contagious diseases and the preservation of health.
4. Advise the County Executive and County Council on health matters including behavioral health.
5. Have the power to administer oaths, issue subpoenas and apply for injunctive relief.
6. At the request of the County Executive or a majority of the County Council, the Frederick County Health Officer (or their alternate) will convene a meeting of the Board of Health to review and make recommendations on any matter related to public health.



Board of Health Membership

Membership =

- ✓ The 7 County Council members
- ✓ The County Executive
- ✓ The Frederick County Health Officer
- ✓ Executive officer and secretary = the Frederick County Health Officer
- ✓ All members have full voting privileges



NEWLiaison Positions - Qualifications

Purpose: Liaisons shall serve as a resource, provide information and data, and answer questions as needed or requested by the Board of Health.

The Board shall appoint the following 6 liaisons:

- An Epidemiologist
- A nurse
- A mental health professional
- A veterinarian
- A member from the Frederick Chamber of Commerce, and
- One (1) person with a science related background



NEWLiaison Positions – Appointment Terms

- Liaisons shall be appointed and confirmed by a majority of the Board of Health
- Liaisons shall have no voting privileges, and will not be counted in determining the presence of a quorum
- Liaisons will serve without compensation.
- With the exception some of the initial appointments, the term of office of each of the members shall be for a period of three (3) years.
 - Of the initial 6 appointed liaisons,
 - 2 shall be appointed for a term that expires in 1 year,
 - 2 shall be appointed for a term that expires in 2 years, and
 - 2 shall be appointed for a term that expires in 3 years



NEWLiaison Positions – Appointment Terms, cont'd

- Liaisons may be reappointed but may not serve more than 2 full consecutive 3-year terms.
- Vacancies shall be filled on the same basis as the original appointments for unexpired terms and shall be filled with a person of the same or similar background of the liaisons being replaced.
- Liaisons shall continue in office until their successors are appointed and qualified.



Board of Health - Meetings

- The Frederick County Board of health shall meet in May and October of each year and at any other time the Board considers necessary.
- Meetings shall take place at a Frederick County location which is open and accessible to the public.
- A majority of the members shall constitute a quorum for the transaction of business.
- Any motion of the Board requires the affirmative vote of at least five (5) members to pass.



Liaison Recruitment – Next Steps in the Process

Determine application content

- Demographic information (name, whether reside/work in FCo, zip code, e-mail address, age decile, R/E, SOGI (optional))
- List to select one of the five liaison areas of expertise applying to fulfill (one per application)
- Questions asking about interest in serving, qualifications, availability for evening in-person meetings, disclosure of potential professional or financial conflict of interest.

Determine recruitment process

- 5 general expertise areas - post Public Notice of recruitment in the Frederick News Post 2 Saturdays in a row in addition to posting on social media, distributing through e-mail distribution channels and issuing a media release. An online and paper application will be available. [see next slide example of draft notice]
- 1 specific organization source – contact Chamber of Commerce directly with same information to solicit a recommendation and completion of an application

The Frederick County Board of Health ("Board") is seeking applications from individuals interested in serving as liaisons on the Board.

The Board shall consist of the seven Frederick County Council members, the County Executive, and the Frederick County Health Officer. The BOH meets in May and October of each year and at any other time it considers necessary.

The Board has the powers and duties granted to a local board of health under State law including those provided in Title 3 of the Health-General Article of the Annotated Code of Maryland. The Board also has the general responsibility for the health and sanitary interest of the people of the County including the investigation and study of the causes of disease, epidemics and nuisances affecting public health, behavioral health, the prevention of contagious diseases and the preservation of health. The Board is to advise the County Executive and County Council on health matters including behavioral health.

1. An epidemiologist;
2. A nurse;
3. A mental health professional;
4. A veterinarian; and
5. One (1) person with a science related background.

The liaisons shall be appointed and confirmed by a majority of the Board. The liaisons shall have no voting privileges and will not be counted in determining the presence of a quorum. The liaisons will serve without compensation.

Liaison Recruitment – Next Steps in the Process

Determine selection process for appointment

- Packet of all applications distributed to all members
- All members review applications – closed session and narrow down to 1 applicant
- All members vote on applications – open session vote on single applicant per category

Are there preferences of interest, for example:

- preference for Frederick County residents and Frederick County workers
- preference for current employment experience in an area of selected expertise
- preference for others, e.g., years of experience in selected expertise, region of county, ??

Assign staggered terms with the areas of expertise with the greatest # of applicants being assigned the shorter initial terms.

Timing - Set July 1 – June 30 as the term to reduce the confusion with the majority (all but 2) of the Boards and Commissions in Frederick County Government. (Ideally the liaisons would be appointed and oriented before the October meeting.)



BoH Liaison – Onboarding Planning

Onboarding to include:

1. Board of Health local and State legislative documents
2. In-person orientation prior to the first Board of Health meeting occurring after appointment
3. Open Meetings Act training
4. Corporate Compliance/Conflict of Interest training
