1. Introductions

Andrea Walker convened the meeting and introductions of meeting attendees occurred.

2. Review/Approval of Minutes

Minutes were reviewed and no corrections were noted. Mrs. Walker made a motion to approve the minutes and the motion was seconded by Sandra Wastler.

3. Announcements

- Mrs. Walker provided an update on the Suicide Prevention PSA. The Health Department received additional funds to push out the PSA via social media outlets and television. This further social media push will be scheduled for future dates. Channel Communications has already started with the social media push for the PSA and engagement numbers/report will be forthcoming.
- Dr. Mandel provided an update on the Responsible Gun Ownership PSA. The PSA has been shared and viewed by various groups to include the VAC and Rotary Club, feedback was received. A QR code was created for feedback on the PSA and allowed the parties who have viewed the PSA to share feedback easily. The PSA feedback is being reviewed and will be discussed in an upcoming meeting with the collaborators of the PSA.

4. Veterans Subcommittee Report Out

- Amanda Adams provided the following report out: The subcommittee is in the stages of finalizing the Ask the Question survey and plan to distribute the survey to identified parties the week of November 27th. The subcommittee is asking others to share the survey with other parties for their participation and completion as they see fit.

6. Subcommittee Report Out

- *Responsible Gun Ownership*: Dr. Mandel provided the report out. The subcommittee discussed ideas of content for a follow-up PSA, 1-2 minutes in length that would focus more on safety and what to expect when calling 988. The PSA would be based on feedback received from the initial shorter PSA and would be more in-depth.
- *Education/Outreach*: Stephanie Shapiro provided the report out. The subcommittee discussed how Ms. Shapiro contacted Living Works about the possibility of tracking how many people utilize Living Works from being connected to the coalition website. The subcommittee also discussed ways the coalition website could be expanded to include hopeful/positive data and put an emphasis on how to help someone who is experiencing suicidal thoughts.
- *Postvention/Support Services following completed/attempted suicide*: Suzy Boisclair provided the report out. Ms. Boisclair advised the presentation was informative and provided hope. The subcommittee reviewed a presentation by Shannon Heath Parkin MS, CPRS who is a multiple suicide attempt survivor and has lived experience. Ms. Heath Parkin is a peer recovery specialist with On Our Own Frederick County.
