1. Introductions

Amanda Adams convened the meeting and introductions of meeting attendees occurred.

2. Review/Approval of Minutes

Minutes were reviewed and no corrections were noted.

3. Announcements

- a. Summer McClellan introduced the current Community Health Needs assessment survey and described its role in the overall Community Health Needs Assessment process. Summer reported the following data from the survey thus far:
 1. 1,900 responses as of today.
 2. The majority of respondents are Caucasian (1,360).
 3. 400 respondents were between the ages of 40-49.
 4. Early results indicate a need for a greater diversity in respondents.

5. Subcommittee Report Out

- a. *Responsible Gun Ownership*: Dr. Mandel provided the report out. The group further explored the PSA that is about to begin. The group is gathering ideas for points of emphasis and considering what the call to action is. The group reviewed data gained from the locally produced PSA that ran in theaters and subsequent feedback. The group continues to look into safe storage facility information and viability.
- b. *Education/Outreach*: Stephanie Shapiro provided the report out. Stephanie secured a no cost vendor table for the “Out of the Darkness” walk which will be held in Baker Park 10/12/24. Stephanie will create a Sign-Up Genius for SPC members to sign-up for working the table at the event. Shannon Parkin volunteered to speak at the event (looking into it with organizers). The group is exploring having focus groups in senior centers in frederick. Need to narrow down the questions: How does the geriatric population want to receive information and resources. Tone to be positive and reduce stigma.
- c. *Postvention/Support Services following completed/attempted suicide*: Kaili Van Waveren provided the report out. The group wants to spend time creating postvention protocol. Summer McClellan created a Teams channel to work in and review resources. Group intends to compile resources over the next weeks. Summer will draft an outline to workshop in next month’s meeting.
- d. *Veterans*: Amanda Adams provided the report out. The group reviewed plans for community trainings about serving veterans and their family members. The group is using a Teams channel to have planning documents available to all. Will get more input next month on what to address next from the Crisis Intercept Map. Amanda reminded all that there is a Veterans event tomorrow at the Prospect Center on Himes Avenue from 10am-2pm.

6. Announcements from BHA Office of Suicide Prevention

Anne Claggett made announcements on behalf of the Office of Suicide Prevention:

- Caring Out Loud Campaign - The office of suicide prevention partnered with the Trevor Project, a leading suicide prevention organization for LGBTQIA+ young people.
