

Level of Community Transmission in Frederick County, MD: **HIGH**



According to [Board of Health Regulation 02-2021](#), masks are required for everyone age 5 years and older in all indoor public places in Frederick County.

Update About Boosters

What did you get?	When can you get a booster?	Who is eligible for a booster?
Pfizer	5 months after 2nd dose	All Marylanders 12 years and older
Moderna	5 months after 2nd dose	All Marylanders 18 years and older
Johnson & Johnson	2 months after single dose	All Marylanders 18 years and older

The period between getting the Moderna COVID-19 vaccine 2nd dose and a booster shot has been shortened to five months from six for people ages 18 and up, which now matches Pfizer booster timing. Marylanders ages 12-17 are eligible for the Pfizer booster only. Marylanders 18 and older may choose which vaccine they want for a booster, even if it is different from the original vaccine received. Reporting Results from At Home Test Kits

If you test positive for COVID-19 with an at-home test kit, please report your result to covidlink.maryland.gov/selfreport. You will need a cell phone number to report your result. - The system will only accept test results within the last 10 days. You will receive a confirmation email with isolation guidelines.

Trending Questions from Maryland Department of Health

What are the new oral COVID-19 antiviral medications and how do I know if I qualify for treatment? Paxlovid and Molnupiravir are newly authorized antiviral COVID-19 medicines that are given in a prescription pill regimen. These are the first oral antiviral treatments that have been given Emergency Use Authorization for adults (Molnupiravir) and children 12 years and older (Paxlovid) who test positive for COVID-19 and who have at least one risk factor for serious disease from COVID-19.

Both Paxlovid and Molnupiravir are prescribed in a five-day pill regimen. These two medications join monoclonal antibody therapy (mAb), which is delivered by intravenous infusion, as treatment options available for those at risk of serious illness from COVID-19.

Patients must consult a physician to determine if either medication is appropriate for their situation and obtain a prescription. For more information, visit [COVID-19 Treatment Options](#).

All Marylanders 5 and older are eligible to get a COVID-19 vaccination. **Please note that only Pfizer is authorized for people 5-17 years old. Children must be accompanied by a parent or guardian.**
