**Welcome**

**Presentation of Requested Regulation**

Dr. Barbara Brookmyer, Health Officer for Frederick County presented the Requested Regulation to the Board of Health Members.

Council President Keegan-Ayer shared that Rick Weldon, the President and CEO of Frederick County Chamber of Commerce, submitted a letter of support to the Board of Health in favor of the changes in regulation BOH 01-2021.

**Board Discussion and Vote**

After discussion and debate the Board approved 7-1 BOH Regulation 01-2021 that did the following:

- removes restrictions on social gatherings involving 25 or more persons
- adds a requirement for certain public gatherings of 100 or more persons to provide to the Health Department information about the gathering
- no longer places occupancy limits on fitness centers or wedding venues

*Council Member Michael Blue moved to approve the Requested Regulation as presented. Council Member Steve McKay seconded the motion that passed 7-1.*
