



Symptoms of COVID-19

People with COVID-19 have had a wide range of symptoms reported – ranging from mild symptoms to severe illness. Symptoms may appear **2-14 days after exposure to the virus**. People with these symptoms may have COVID-19:

- Fever or chills
- Cough
- Shortness of breath or difficulty breathing
- Fatigue
- Muscle or body aches
- Headache
- New loss of taste or smell
- Sore throat
- Congestion or runny nose
- Nausea or vomiting
- Diarrhea



This list does not include all possible symptoms.

Isolation VS. Quarantine

Isolation - Infected

- Have positive COVID-19 test
- Can last 10+ days

Quarantine - Contact

- Have close, prolonged contact with someone with positive COVID-19 test
- Must last 14 days (incubation period)
- Testing negative does NOT end sooner than 14 days




WHO Coronavirus Disease (COVID-19) Dashboard






Cases in Maryland






Frederick County COVID-19 Deaths by Week






Positivity Rate and Case Rate



Frederick County, MD COVID-19: Testing Volume per Day




Frederick County, MD COVID-19: Positive Tests per Day




Frederick County Covid-19 Hospitalizations

Frederick County COVID Cases - High Risk Gatherings by Week





In a gathering of 50 persons in Frederick County what is the chance of someone currently being infected? 50%





Currently in Place in Maryland

- Governor Hogan's Executive Order 20-11-17-01
 - *At 50% maximum occupancy:*
 - Religious facilities, Retail and Malls, Personal Services, Other Recreational Establishments, Foodservice Establishments, **Fitness Centers**, Casinos
 - *Theaters, Outdoor Entertainment*
 - Indoor theaters 50% or 100 persons, whichever is less
 - Outdoor entertainment or sporting venues 50% or 250, whichever is less
 - *Face coverings required for all persons in Maryland over 5 years*
 - Indoors in any public location
 - Outdoors and unable to consistently maintain 6 feet distance
 - Exceptions



Gov. E.O.: The following restrictions are effective Friday, November 20, 2020 at 5:00 PM:

- All “Foodservice Establishments” will close between 10:00 p.m. and 6:00 a.m., except for carryout and delivery;
 - * “Foodservice Establishments” is a collective term that *includes* “(a) restaurants, bars, nightclubs, banquet and catering halls, and other similar **establishments that sell and/or serve food or beverages for consumption on premises**” and “(b) **Social Clubs with dining facilities**”
- The following businesses will operate at 50% capacity:
 - ❖ *Retail businesses*
 - ❖ *Organizations*
 - ❖ *Religious institutions*
 - ❖ *Personal services*
 - ❖ *Bingo halls*
 - ❖ *Bowling alleys*
 - ❖ *Pool halls*
 - ❖ *Skating rinks*
 - ❖ *Fitness centers*
 - ❖ *Social clubs*



Gov. E.O.: The following restrictions are effective Friday, November 20, 2020 at 5:00 PM:

- Fans will not be permitted at professional or collegiate stadiums or racetracks;
- Hospital visits are suspended, with certain exceptions. Exceptions include: compassionate care, obstetrics, parents/guardians of minors, and for people with disabilities;
- Hospitals are urged to avoid admitting patients for elective procedures;
- Allow hospitals that are full or near capacity limits to transfer patients to hospitals or alternative care sites as appropriate; MIEMSS will provide coordination;
- Nursing home visits are suspended, except cases involving compassionate care. Visitors must have proof of a negative COVID-19 test result 72 hours prior to their visit; and
- Nursing homes will test residents weekly and employees twice a week.



Proposed Frederick County Regulation Clarifications - same wording

A. Face coverings:

1. *Face coverings need to be worn by all persons over 5 years*
 - In all indoor public spaces
 - In all outdoor public spaces where unable to maintain 6 ft distance
2. *Face coverings should be worn except when eating or drinking food or beverages.*
 - This does not apply to using tobacco products, smoking and vaping paraphernalia.



Proposed Frederick County Regulation Clarifications - improved wording

B. Limitation on Gathering Size:

1. *All provisions in Gov. Executive Order apply except that social gatherings shall be limited as follows:*
 - a. *Indoor social gatherings of more than 25 persons are prohibited*
 - b. *Outdoor social gatherings of more than 25 persons are prohibited*
2. A “social gathering” includes parties, cookouts, parades, celebrations, festivals, conventions, and fundraisers.

Does not include normal business operations.

Proposed Frederick County Regulation Clarifications – improved wording

(B) Limitation on Gathering Size:

(3) *Wedding venues* - limited to 50% maximum occupancy or the occupancy for food service establishments, whichever is less.

- a. Modify floor plans so tables are at least 6ft apart
- b. Make 6 ft marking system to show social distancing for staff and guests
- c. Persons may not sit or congregate at bar if one is present
- d. Bar should be 6 ft from seated guests
- e. Tables and high touch surfaces shall be cleaned and disinfected between each seating
- f. Food may not be served in buffet or self-serve format
- g. Guests must remain seated. No dancing or congregating in groups.
- h. Venue staff must wear face coverings unless unsafe to do so
- i. Venue staff must be trained in COVID-19 health guidance
- j. Venue staff who become sick must follow MDH isolation and quarantine guidance.
- k. Goes into effect 11/30 at 9am



Proposed Frederick County Regulation Clarifications – No wording change

(B) Limitation on Gathering Size:

(4) Fitness centers

- a. Require face coverings on all persons on premises with Governor's Executive Order exceptions
- b. Limited to 25% maximum occupancy

A. *Citations for violation will be a fine*

- i. \$250 for a first offense
- ii. \$375 for a second offense
- iii. \$500 for a third or subsequent offense


