






### Frederick County Percent Positive Rate (7-Day Avg)

● Frederick ● State Wide




### Frederick County Case Rate per 100K (7 Day Moving Average)





# Frederick County Congregate Facility Outbreaks







#### Frederick Health Hospital Implements Crisis Standards of Care Effective January 3, 2022.

**Frederick, MD. (January 3, 2022)** – Frederick Health is experiencing unprecedented patient volumes and staffing shortages due to the latest surge of COVID-19 cases. On December 28, 2021, Frederick Health Hospital saw a dramatic increase in COVID-19 hospitalizations, and inpatient volumes continue to surpass volumes seen during previous COVID-19 surges. Effective January 3, 2022, Frederick Health Hospital is implementing crisis standards of care, allowing the hospital and health system to extend vital resources and minimize the impact on the healthcare team and the community we serve.

This action will enable Frederick Health to care for the rapidly increasing number of patients most safely and effectively during this crisis. Under crisis standards of care, changes to protocols may include:

- Modifying surgical schedules consistent with the Governor's recent orders
- Expediting hospital discharges, when safe and appropriate
- Transitioning to telehealth care options when applicable
- Simplifying documentation
- Redeploying clinical and non-clinical staff to areas of greatest need



# Monoclonal Antibody Treatment




- Frederick Health has resumed monoclonal antibody treatment


**Adolescents & teens ages 12 to 18 years old who received a COVID-19 vaccine should get a booster.**

They can get their booster at least 5 months after completing their primary Pfizer-BioNTech series.



# CDC Isolation & Quarantine Update

- CDC Guidance has updated now
- MDH today adopted CDC guidance
- If following CDC guidance, *very important* to follow whole guidance for days 6-10: “avoid eating around others at home and at work until a full 10 days after your first day of symptoms.”





# Board of Health's Adopted Regulation in Effect – Regulation Number 02-2021

The adopted regulation does not have an enforcement component.

Customers concerned about employees or other customers not masking should let the management know of their concerns so that they are aware that customers are looking for them to follow the regulation.

# Actions taken since last BOH meeting

- County Executive and County Council sent letter to Governor Hogan and Secretary Schrader requesting state support to expand capacity at an existing COVID-19 testing operation site as well as for a state operated additional COVID-19 testing center in Frederick County.

Frederick County Government made significant investments in the local test capacity by supporting the standing up of the FHH drive through operations last year and expanding the lab processing capacity and throughput. While a State operated testing clinic would be beneficial, **it would be immediately beneficial for the State to provide staffing resource support to FHH so that they can expand the capacity at the current drive through testing location and send the lab specimens to FHH for processing.**

State support to expand testing capacity would greatly assist and reduce the strain on our hospital, most specifically the Emergency Department, allowing patients in need of care to get that care more quickly.

We urge your prompt attention to this urgent request. We look forward to working with your team and remain optimistic for a better year in 2022.




# Testing Capacity Expansion

- State support testing operation to start next week
- FCHD Hillcrest site – 50% increase already with existing staff this week with expanded space and on target for full doubling with extra staff
- Go to [Covidtest.Maryland.gov](https://Covidtest.Maryland.gov) to see local options for testing including drive-through
- State supplied at-home test kits = since November 16 = total of 6,864




# Non-Healthcare Employers

- Please DO NOT require negative tests to return to work! (This adds to longer lines!)
- Employees who tested positive for COVID-19 are cleared to work when they have completed isolation
- Some people may continue to test positive for up to 90 days, but should not be excluded from work
