




Frederick County Percent Positive Rate (7-Day Avg)

● Frederick ● State Wide




Frederick County Case Rate per 100K (7 Day Moving Average)




Frederick County 7 Day Moving Average of Confirmed Cases by Age Group by Day









(all deaths for COVID+ cases)







TRANSMISSIBILITY & CASE NUMBERS

Omicron's transmissibility is as infectious as scientists suspected.

Unlike our previous experience with COVID-19 "hotspots" flaring up across the US at various times, omicron is showing up everywhere at the same time.

Case numbers are setting record highs but are likely much higher due to an overall lack of rapid testing, an inability to find PCR test appointments, and under-reported at-home test results.*

****If you test positive, you should isolate and inform your health care provider, or your local health department, and it's a good idea to notify your close contacts. Call your primary care provider if you have one and/or check your local health department's website for reporting forms.***









Updates from Governor Hogan Jan. 13

NEW COVID-19 ACTIONS: JAN. 13, 2022



Six new hospital-based testing sites to open by the end of next week



New MDH order requires nursing home staff to be tested 2x a week; visitors must provide negative COVID-19 test to enter



National Guard will distribute Remdesivir to pharmacies serving nursing homes



MDH will distribute 20 million N95 and KN95 masks free of charge beginning next week

- Beginning next week, the Maryland Department of Health will distribute 20 million N95 and KN95 masks at no cost through multiple channels, including local health departments, state-run testing and vaccination sites, and nursing homes. *No additional details yet.*
- Over the next few days, the Maryland National Guard will begin distributing courses of Remdesivir, which is one of the therapeutic treatments believed to be effective against the Omicron variant, to institutional pharmacies that directly serve nursing homes.



Treatment Options

- Paxlovid and Molnupiravir are newly authorized antiviral COVID-19 medicines that are given in a prescription pill regimen. These are the first oral antiviral treatments that have been given Emergency Use Authorization for adults (Molnupiravir) and children 12 years and older (Paxlovid) who test positive for COVID-19 and who have at least one risk factor for serious disease from COVID-19.
- Both Paxlovid and Molnupiravir are prescribed in a five-day pill regimen. These two medications join monoclonal antibody therapy (mAb), which is delivered by intravenous infusion, as treatment options available for those at risk of serious illness from COVID-19.
- Patients must consult a physician to determine if either medication is appropriate for their situation and obtain a prescription.


