

Test Kits

Get Reimbursed:

Most people with health insurance can be reimbursed for COVID-19 at home test kits purchased on or after January 15, 2022. Insurance companies are required to reimburse for up to \$12 per test and up to 8 tests per month for each person on your insurance plan.



Free Test Kits

Order from Federal Government:

Every home in the United States is eligible to order four free at-home COVID-19 rapid antigen tests. Orders will usually ship in 7-12 days. Go to covidtests.gov.

Test Kits from Frederick County:

More test kits have been ordered! Details about future distributions will be shared on social media and on <https://frederickcountymd.gov/CovidTest>.

Reporting Positive Results

You can report positive test results either through the mobile app associated with your at-home test or through the Maryland COVID Positive At-Home Test Report Portal. Reporting positive results here will initiate the contact tracing process, which may be required to receive work or school excuse and release letters, which will help to keep others safe. [Log in on the portal's home page to submit a report](#). If you do not have login information, you may register to create an account.

Change to Testing Hours

Frederick Health has expanded the hours for their COVID-19 drive-thru testing site located at Frederick Health Village. Testing occurs daily from 7 a.m. - 3 p.m.

Frederick Health now requires a COVID-19 test order for any testing performed at the Frederick Health Village testing site. You can call 240-316-4970 between 8 a.m. and 5 p.m., seven days a week, in advance of your test to get your order. Visit FrederickHealth.org/COVIDtesting for more details.

Booster Doses


Have you gotten your COVID-19 booster? Make sure you're up to date!

Up to date means a person has received all recommended COVID-19 vaccines, including any booster dose(s) when eligible.

FDA Updates

On January 31, the FDA gave full approval for Moderna's COVID-19 vaccine for the prevention of COVID-19 disease in individuals 18 years of age and older. The vaccine remains available under EUA as a two-dose primary series for individuals 18 years of age & older and as a third dose for certain immunocompromised individuals. A booster of the vaccine is also available under the EUA.

Frederick Vaccination Update

All Marylanders 5 and older are eligible to get a COVID-19 vaccination. **Please note that only Pfizer is authorized for people 5-17 years old. Children must be accompanied by a parent or guardian.**
