### 1. Welcome and Introductions/Approval of Minutes

- Todd opened the meeting at 3:00pm with welcoming remarks and asked members to sign in via the “chat”.
- The November 2024 TAC minutes were approved as submitted.

### 2. Legislative Updates from the Legal Resource Center

- George Townsend, Staff Attorney with the Legal Resource Center for Public Health Policy – Cannabis, is the point of contact for Frederick County as it relates to cannabis information from the LRC.
  - i. George shared that currently there are 6 “pre-filed” bills related to cannabis for the 2025 legislative session. Some of the bills are administrative. One main bill to watch in 2025 is the proposed on-site cannabis consumption sites bill. Currently, no on-site cannabis consumption sites exist in Maryland.
  - ii. The LRC will provide a tracking spreadsheet for any public health bills proposed in Maryland. The Tobacco and Cannabis side of the LRC will host virtual meetings to provide updates about proposed legislation.

### 3. Updates from MDH

- Michelle Jenkins from MDH provided an update related to documentation specific to the Tobacco Modernization Act. Local health department meetings are being conducted, and jurisdictions are being informed how to respond to new modernization act legislation.

### 4. Round Robin/Updates from Coalition Members

- Clifton Jackson, LWYW: Received a mini-grant through FCHD to provide tobacco merchant education. Working on completing the 200 merchant education visits.
- Martin Scarborough with the Frederick Center: Brought onboard a Peer Support Specialist. Is present in the youth programs and have offered support on substance use (2 anonymous youth) on how to quit and other guidance.
- Carly Schepacarter, KLU: KLU goes into schools and partners with counselors to provide support to youth that have family members with substance abuse concerns. KLU was just published for their recruitment procedures. Link was shared in the chat. 308 students in grades 4<sup>TH</sup>-12<sup>TH</sup> are enrolled in KLU.

## 5. FCHD Prevention Program Updates

- Tobacco Use Prevention and Cessation
  - i. The program will be participating in the upcoming Turkey Distribution event later in the month. Cessation numbers seem higher this year than last at this point in the fiscal year.
- Tobacco Merchant Education and Enforcement
  - i. The Tobacco Sales Enforcement Officer has been hired. Former police officer and currently works within the DC Metropolitan area doing red light camera enforcement. New staff member will be onboarded and operational soon.
- Substance Abuse Block Grant
  - i. Todd stated that the FCLB continues to deliver RBS trainings to alcohol licensees in the county. RBS trainings assist licensees verify age of customers and ways to spot and prevent over-service.
  - ii. The FCLB is also conducting compliance inspections of the alcohol licensees in the county.
- Tobacco, Diabetes and Chronic Disease Prevention & Management Grant
  - i. Danielle shared some information about upcoming social media campaigns.
  - ii. The HEO continues to build capacity and increase support for local NGO's.
