Update on COVID-19 Vaccine

27,150 total 1st doses of COVID-19 vaccine received by <u>Frederick County Health Department</u> to date. **2,500** 1st doses of COVID-19 vaccine received by <u>Frederick County Health Department</u> this week.

Currently Eligible in Maryland and Frederick County

People in groups 1A, 1B, 1C, 2A and 2B are currently eligible in Maryland and Frederick County. Once your group is eligible, it continues to stay eligible. There is not enough vaccine for everyone who is eligible.

Phase	Who	When
2A	All Marylanders age 60 and older.	March 23
2B	Marylanders age 16 and older with underlying medical conditions that increase the risk for severe COVID-19 illness.	March 30
2C	All Marylanders age 55 and older, as well as essential workers in critical industries, including construction workers, food services, utilities, transportation, financial services, IT and other infrastructure.	April 13
3	General population, including healthy adults age 16 and older.	April 27

Current Process for Frederick County Health Department

Anyone who lives or works in Frederick County who is interested in getting COVID-19 vaccine should complete the Vaccine Interest Form in the blue box on our <u>Vaccine webpage</u>.

- o It may be several days, weeks, or longer until you are contacted since it depends on vaccine availability. You only need to complete the form once.
- o If you have already scheduled or received your 1st dose of vaccine, please <u>click this link</u> to unsubscribe from the list.
- o The Health Department is in communication with medical providers to refer homebound individuals.

Process for Other Vaccination Clinics

Frequently Asked Questions

Question: What proof do I need to bring with me to my appointment?

Answer: Please bring documentation of your age and identity. You must be over 18 years to receive Moderna and Johnson & Johnson, and over 16 years to receive Pfizer. You do not need a letter from your health care provider as proof of a medical condition.

Question: How can I find a specific type of vaccine?

Answer: Check https://vaccinefinder.org/ to find a specific kind of vaccine, and then call the location to verify their supply.

Other Frederick County Updates

According to Frederick County Board of Health Regulation 01-2021, a responsible person(s) must be designated by the organizer for social gatherings (including parades, festivals, and fund raisers) where the general public is likely to attend and in which 100 or more persons are expected or likely to be in attendance.



This does not apply to social gatherings on personal private property that the public in general is not expected to attend (including reunions, cookouts, and parties).

Event Organizer must complete <u>the online submission form</u> no later than 7 days prior to the event date. Failure to submit the required form and information by the required timeframe may result in the denial of necessary permits needed to hold the event.

Event Organizers are responsible for ensuring compliance at the gathering with face covering and physical distancing requirements, occupancy limits, and other infection transmission mitigation actions, and must remain on-site during the gathering.
