Mission and Vision

MISSION

The mission of the Prevention and Health Promotion Administration is to protect, promote and improve the health and well-being of all Marylanders and their families through provision of public health leadership and through community-based public health efforts in partnership with local health departments, providers, community based organizations, and public and private sector agencies, giving special attention to at-risk and vulnerable populations.

VISION

The Prevention and Health Promotion Administration envisions a future in which all Marylanders and their families enjoy optimal health and well-being.

Maryland YRBS/YTS Overview

- The Maryland YRBS/YTS combines the Youth Risk Behavior Survey and Youth Tobacco Survey into one survey instrument.
- Collects data on middle school and high school health risk behaviors.
- Required by state statute every other even calendar year.
- Delayed from fall 2020 to fall 2021 due to COVID-19.
- This presentation will focus on on the high school estimates and reference what was seen on the middle school survey.
- Baltimore City fell below the 60% required response rate.

By the Numbers: 2021-22 MD YRBS/YTS

- **Survey Administration from September 27, 2021 - January 28, 2022**

- 369 Schools Selected
 - 182 participating middle schools*
 - 184 participating high schools*
 - 1 ineligible school*
 - *2 excused for traumatic loss*

- **57,991 students completed surveys**

- 21,522 middle school students
- 36,469 high school students

- **Over 75% overall response rate**

- 77% middle school response rate
- 73% high school response rate

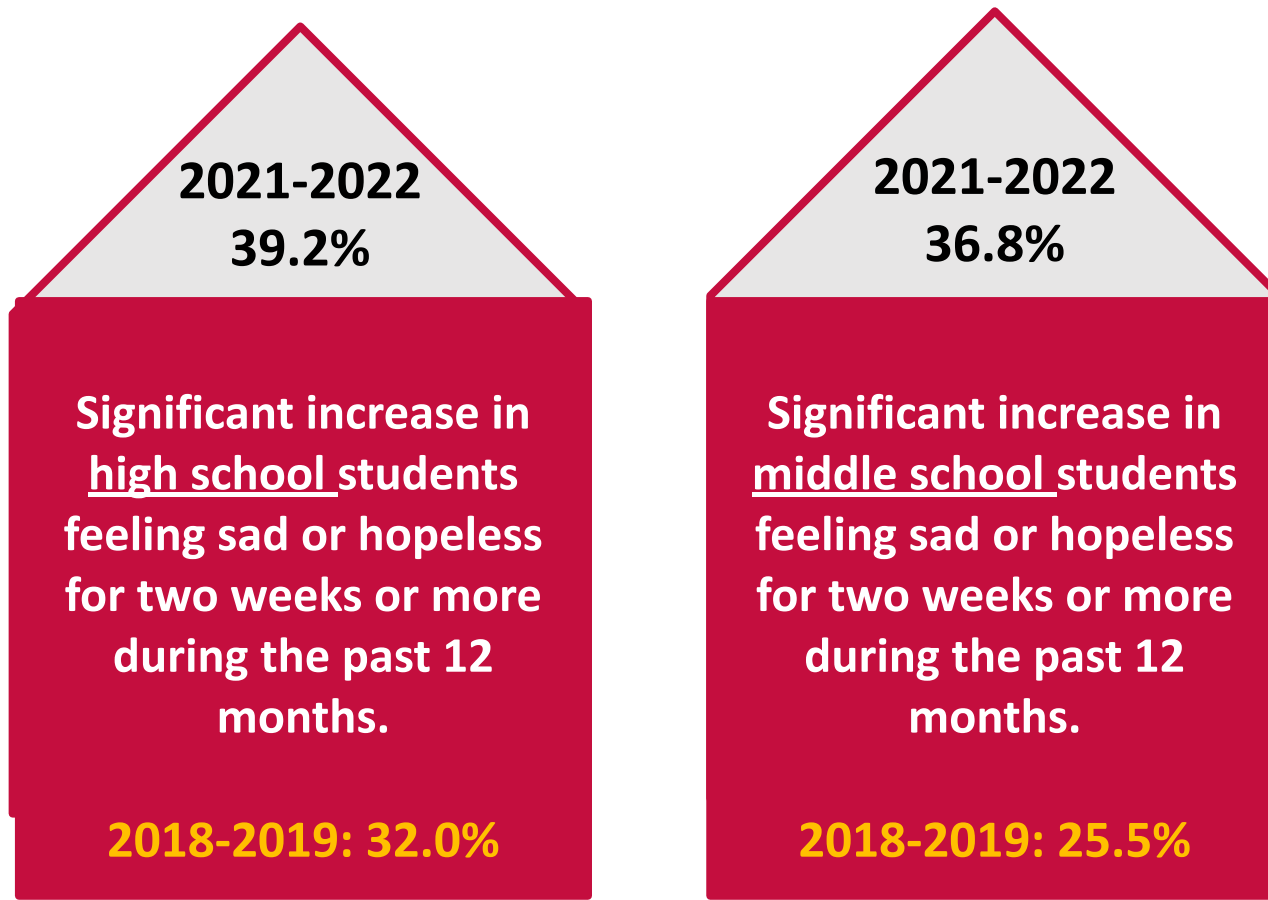
Overall Trends from the 2021-2022 YRBS/YTS

- Despite the return to in-person learning environments, Maryland's students are undoubtedly still feeling the effects of the pandemic which have contributed to the poor mental health outcomes found on the most recent YRBS/YTS.
 - Female students and students identifying as LGBTQ+ were significantly more likely to report these mental health issues.
- Changes in youth lives related to virtual learning and social isolation may have contributed to the rapid decline of most substance misuse including tobacco, alcohol, marijuana, and other illicit substances.

Overall Mental Health

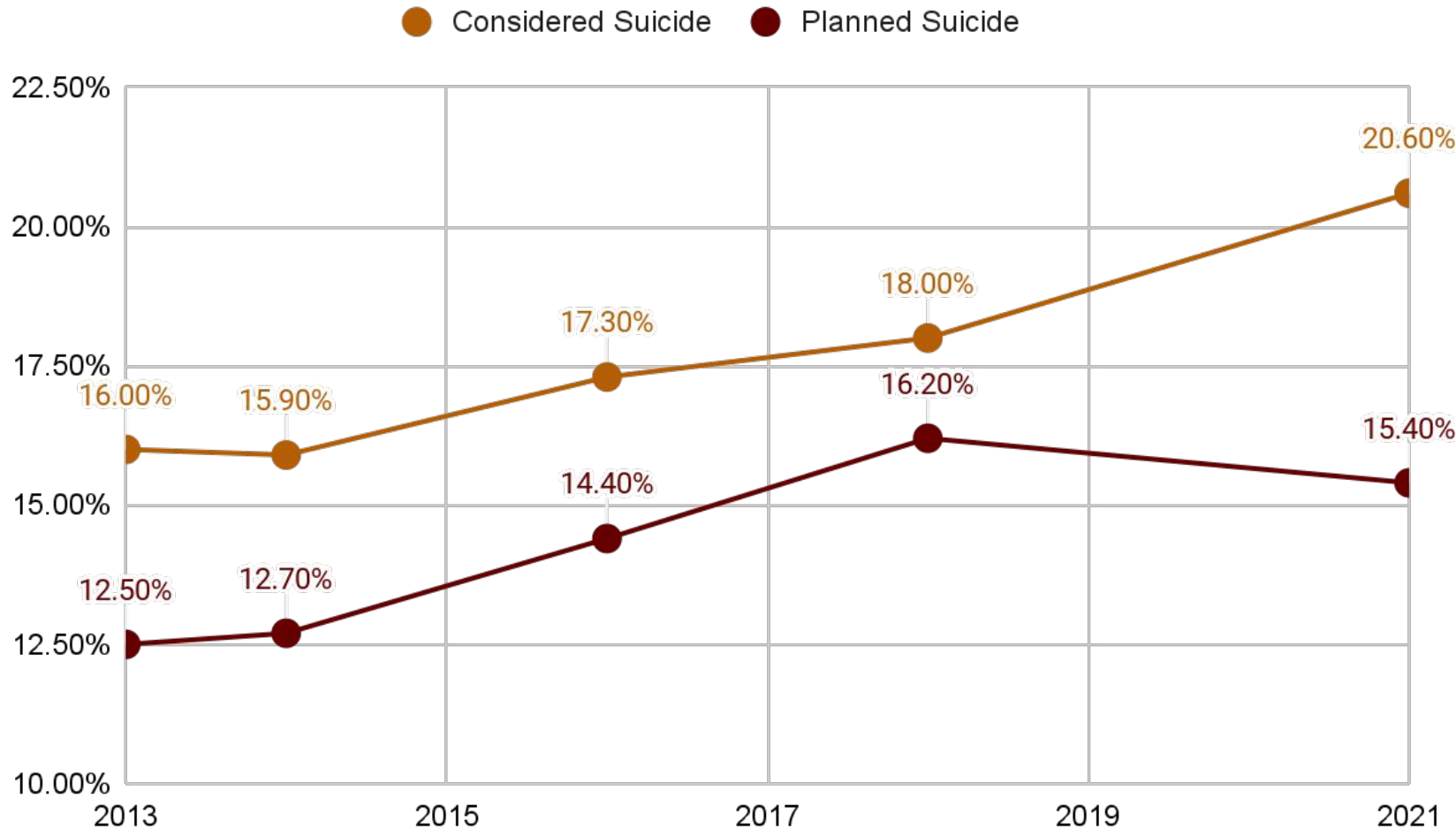


High School: 64.6 percent of students identifying as LGB, 59.4 percent of other/questioning, and 69.3 percent of Transgender students reported being sad or hopeless.

New Mental Health Question!

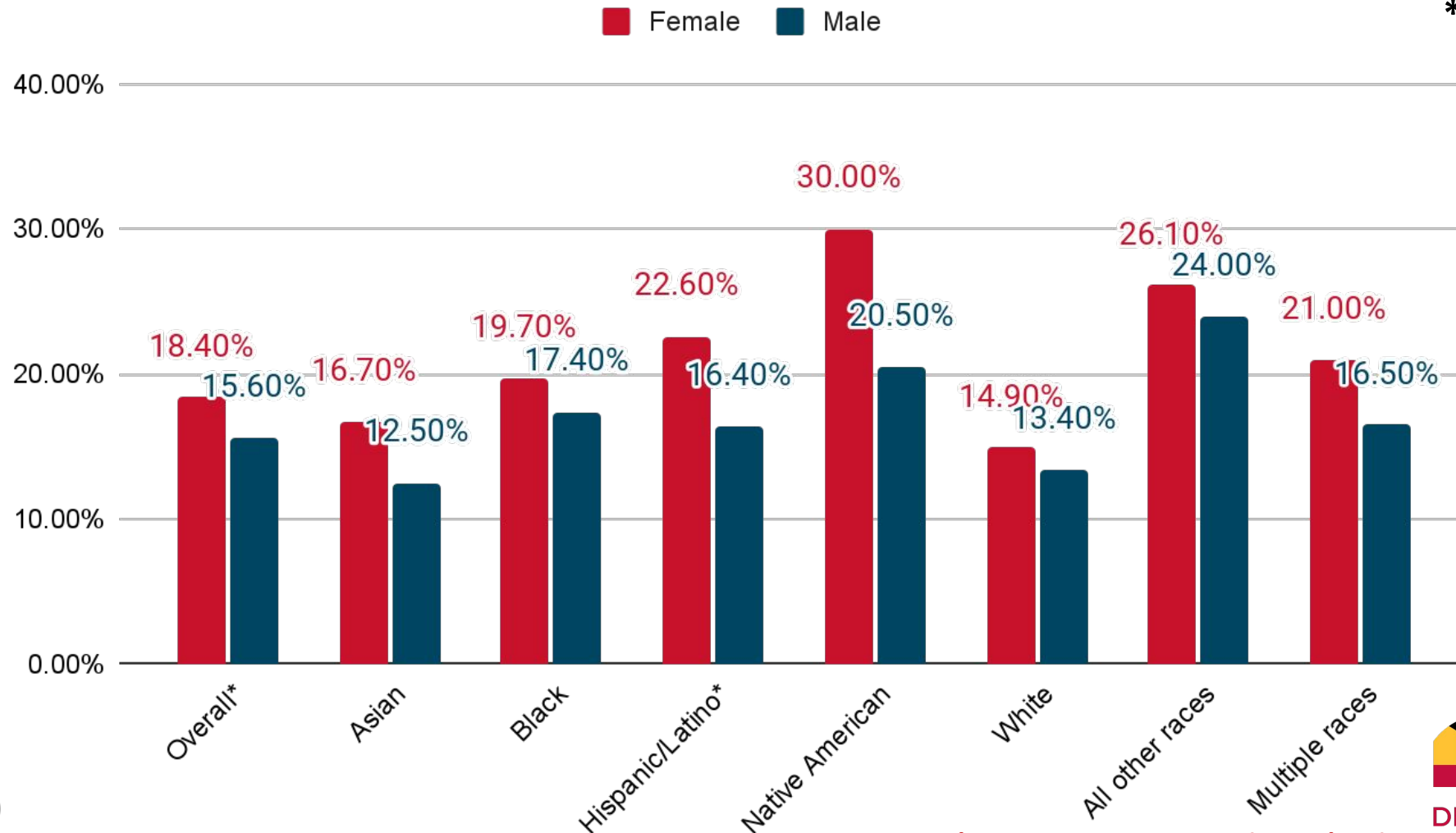
- 29 percent of high school and 23 percent of middle school students reported that their mental health was most of the time or always not good (including stress, anxiety, and depression, during past 30 days)

Suicidal Ideation (past 12 months)



- Significant increase for high school students considering suicide between 2018 and 2021.
- No significant change for planning suicide between 2018 to 2021. However there has been a significant increase since 2013.

Suicide Attempt



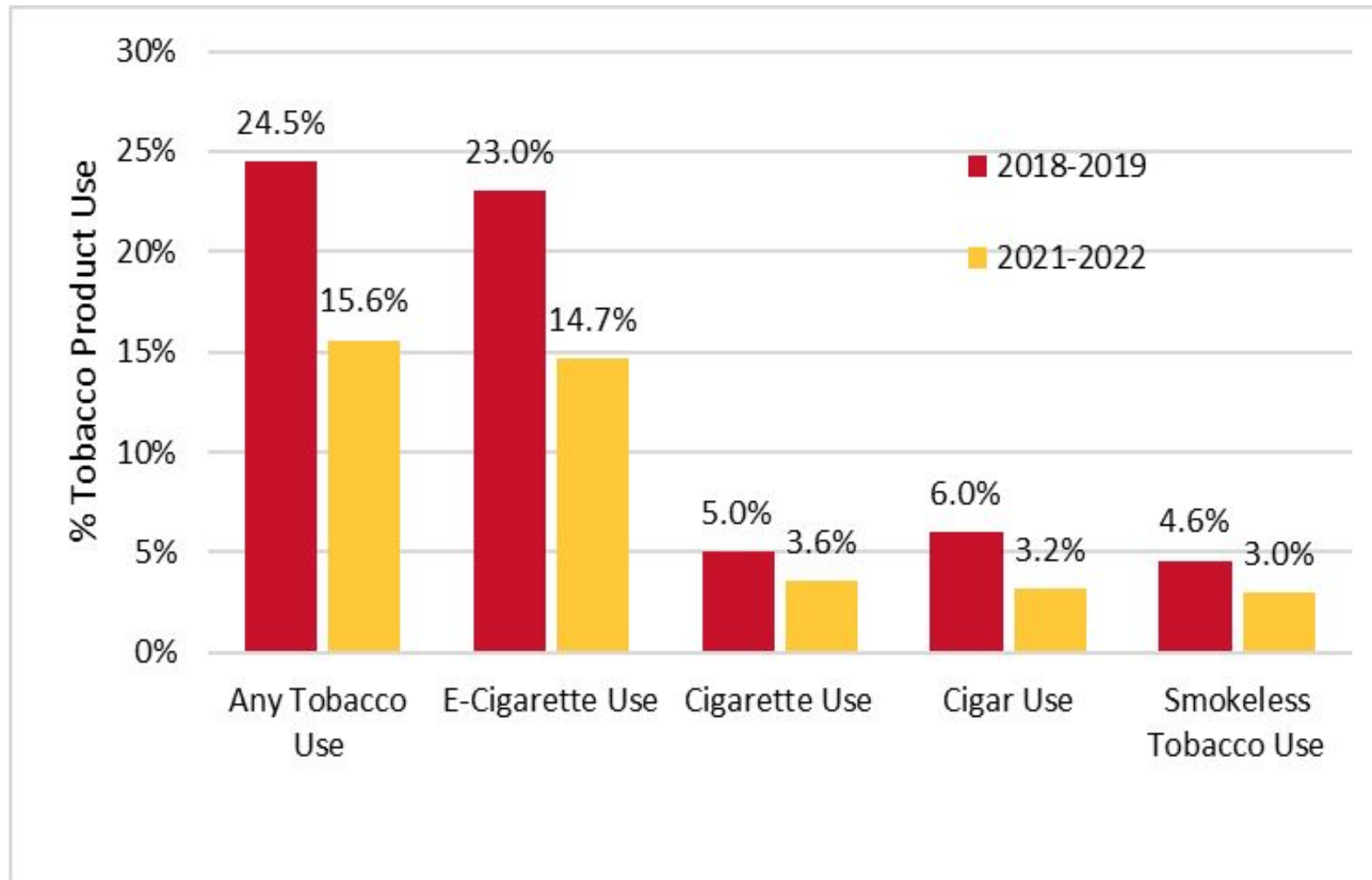
*Significant difference

- **17.3** percent of high school students reported actually attempting suicide in the last 12 months.
- **11** percent of middle school students ever actually tried to kill themselves.

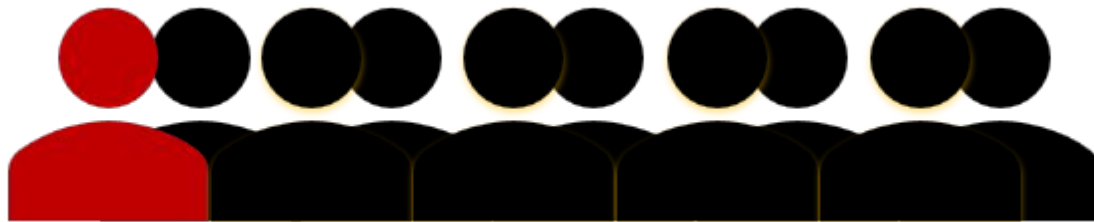
Substance Use

Significant decrease across all tobacco products between survey years 2018-19 and 2021-22.

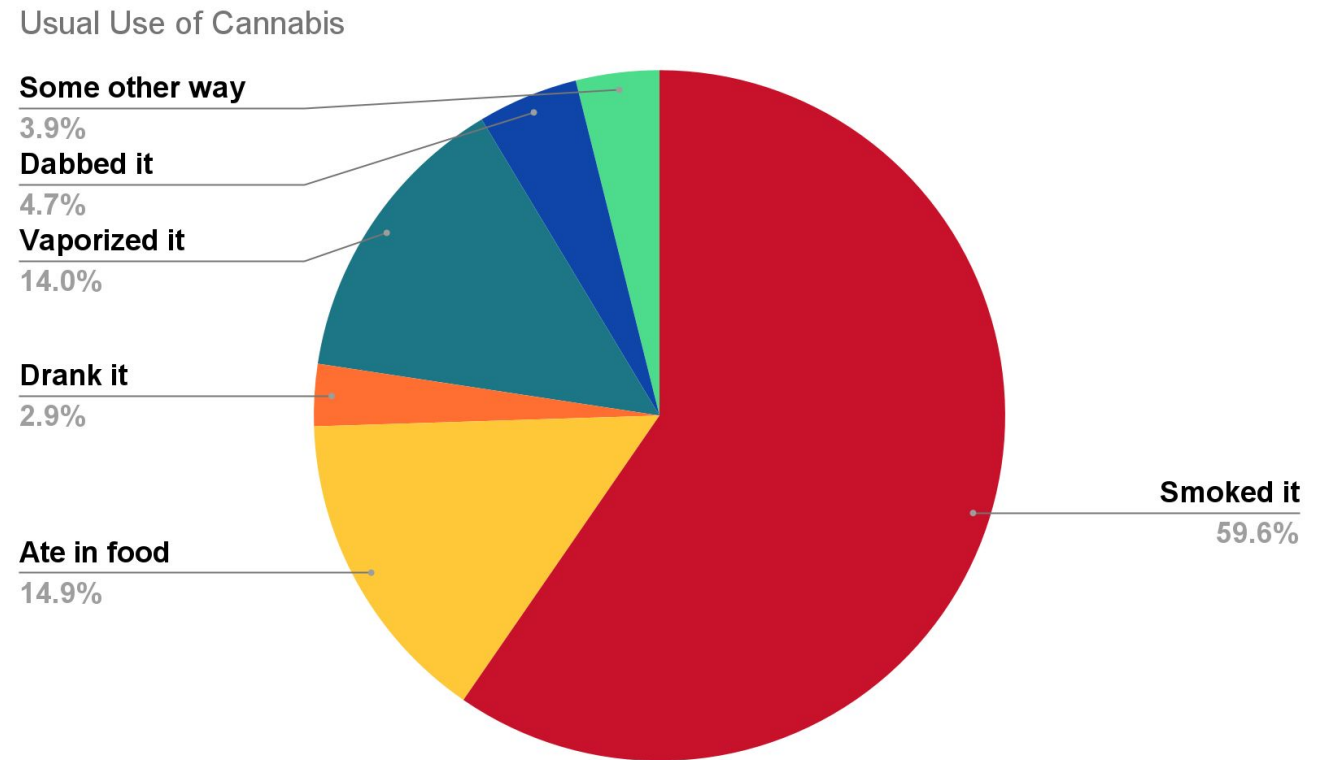
Current Alcohol Use



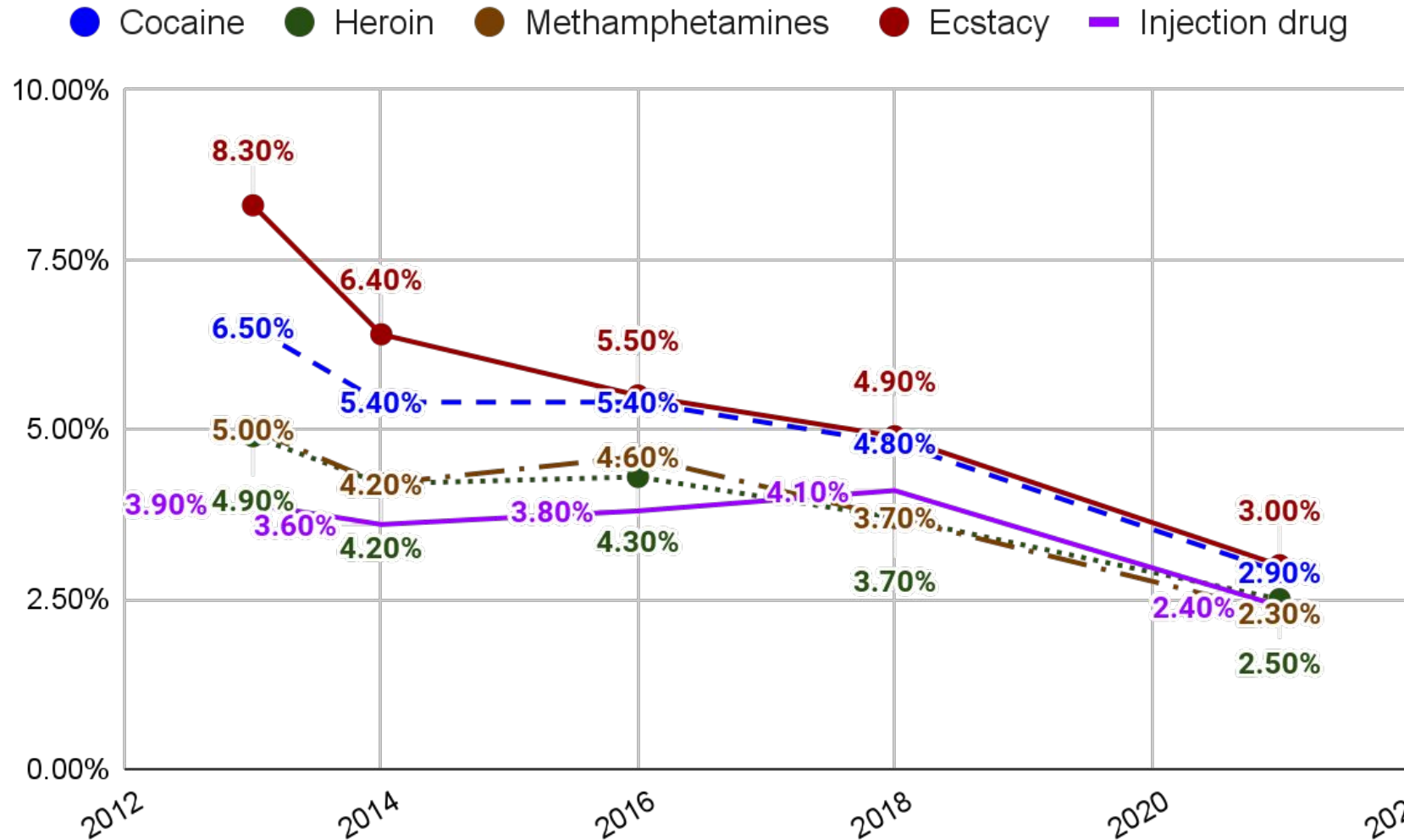
- About **1 in 5 (19.4 percent)** high school students currently drink alcohol. Down from a third of students in 2013.
- Close to **1 in 10 (9.8 percent)** binge drank in the past 30 days. Down from 13 percent in 2016.

Current Cannabis Use

- With the upcoming legalization of adult cannabis possession and use in July, the baseline for current cannabis use among high school students is important to know.
- **15.0 percent** of high school students reported past 30 day use of cannabis. Down from 19.8 percent in 2013.



Ever Other Drug Use



- Sharp declines in illicit drug use among high school students
- **14.6 percent** of high school students reported prescription drug misuse.

Substance Use Disparities

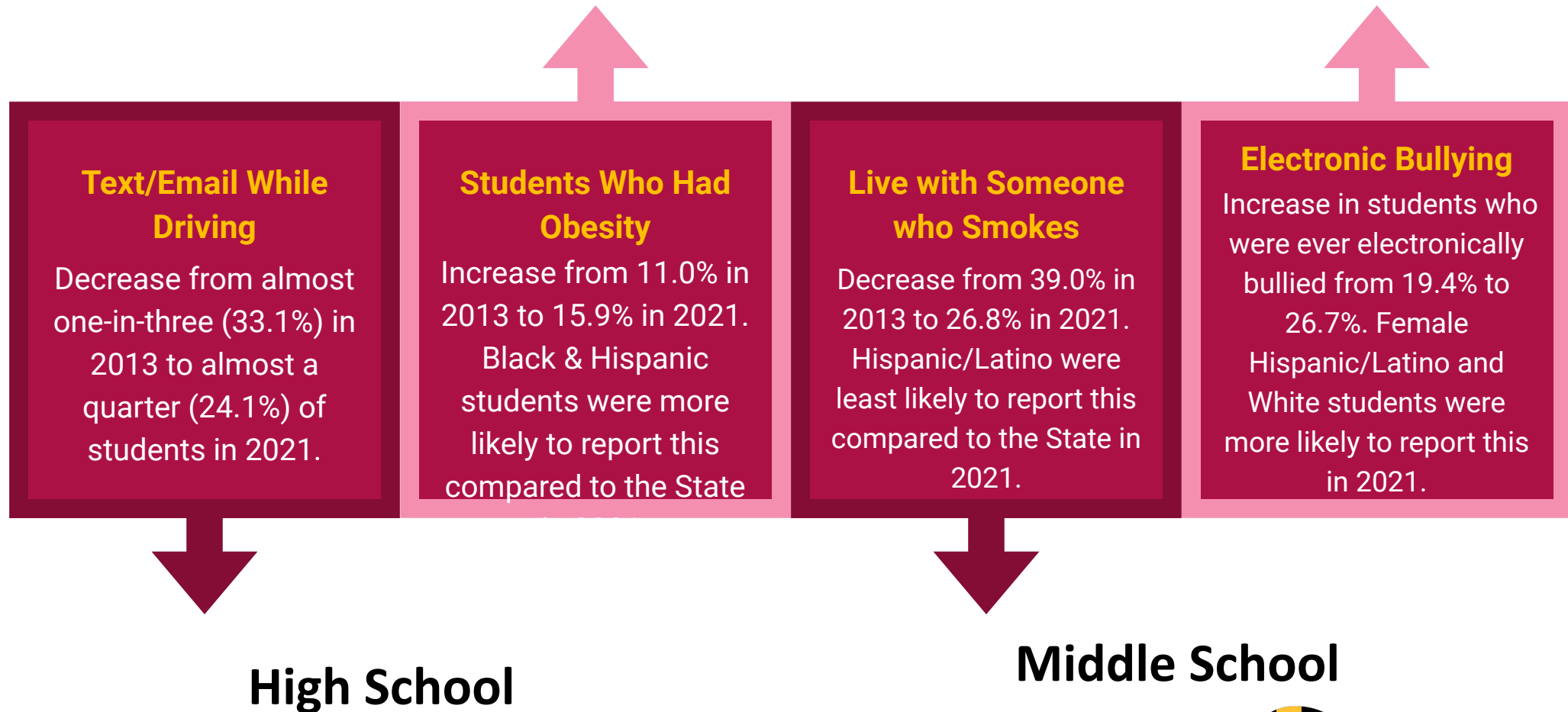
- About a quarter (**24.9 percent**) of HS students identifying as lesbian, gay or bisexual (LGB) used a tobacco product compared to **14.0 percent** of heterosexual (straight) students and **22.2 percent** of HS students identifying as transgender used a tobacco product compared to **15.3 percent** of cisgender students.
- Both middle (**6.1 percent**) and high school (**16.2 percent**) *female* students use marijuana more than *male* middle (**4.2 percent**) and high school (**13.6 percent**) students.
- Prescription drug misuse among middle school students increased from **7.1 percent** to **11.5 percent** between 2018 and 2021.

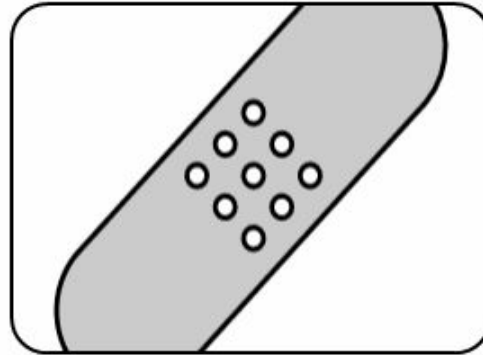

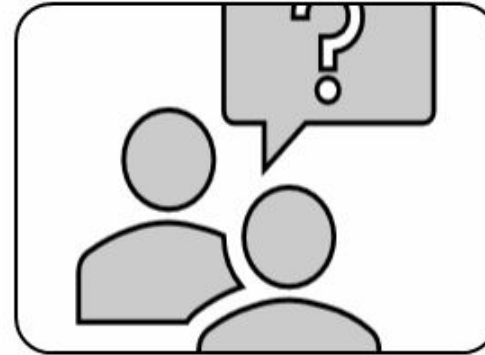
New Topics on the 2021-2022 YRBS/YTS



7.6% of middle school and **10.1%** of high school students who reported that they have a disability or long-term health problem that keeps them from doing everyday activities.



21.5% of middle school students ever saw someone get physically attacked, beaten, stabbed, or shot in their neighborhood. Significantly more likely among Black and Hispanic/Latino students.



Almost three-in-four (72.3%) high school students would feel comfortable seeking help from one or more adults besides their parents if they had an important question affecting their life.

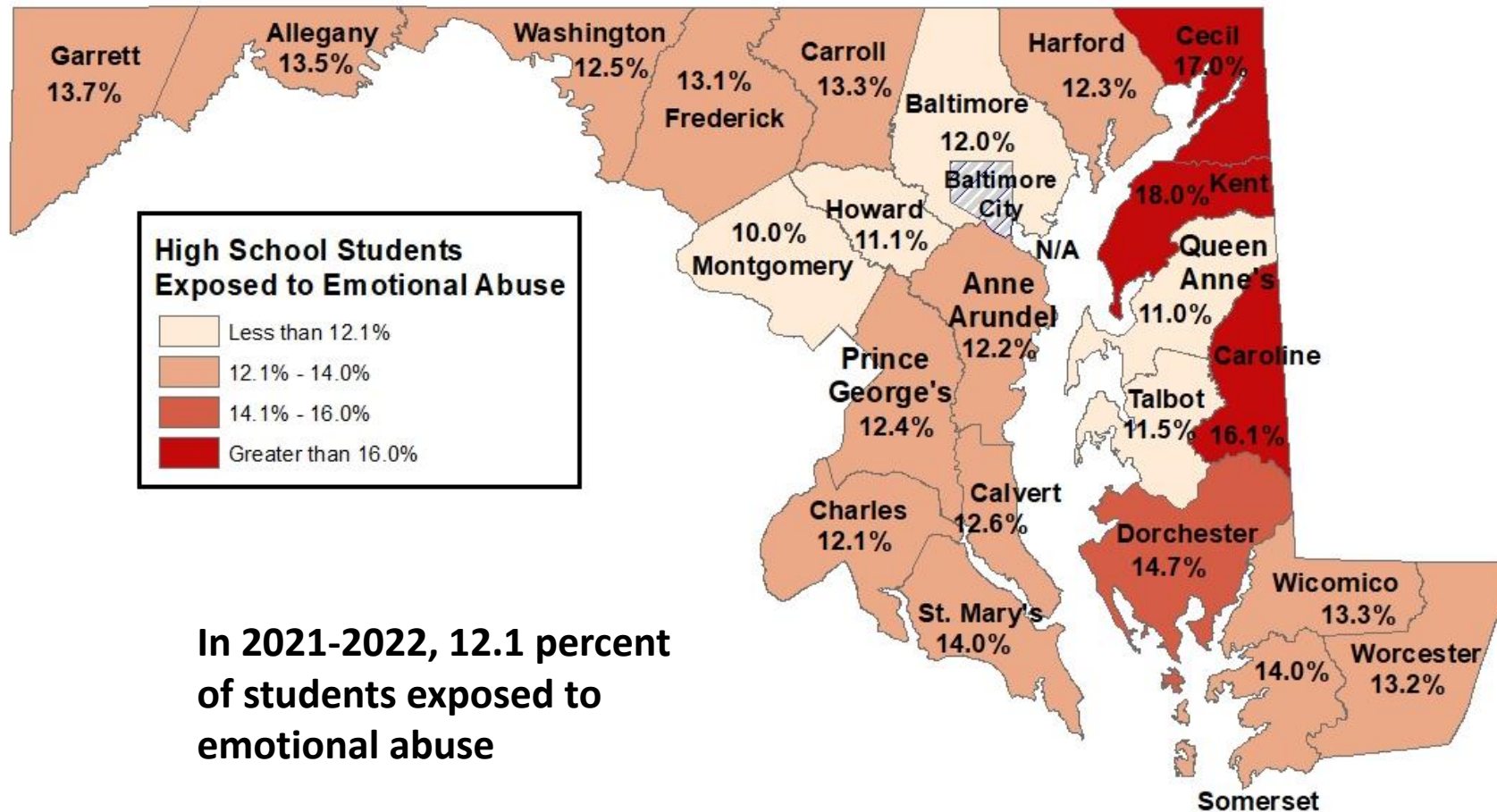

Emotional Abuse (MAP)



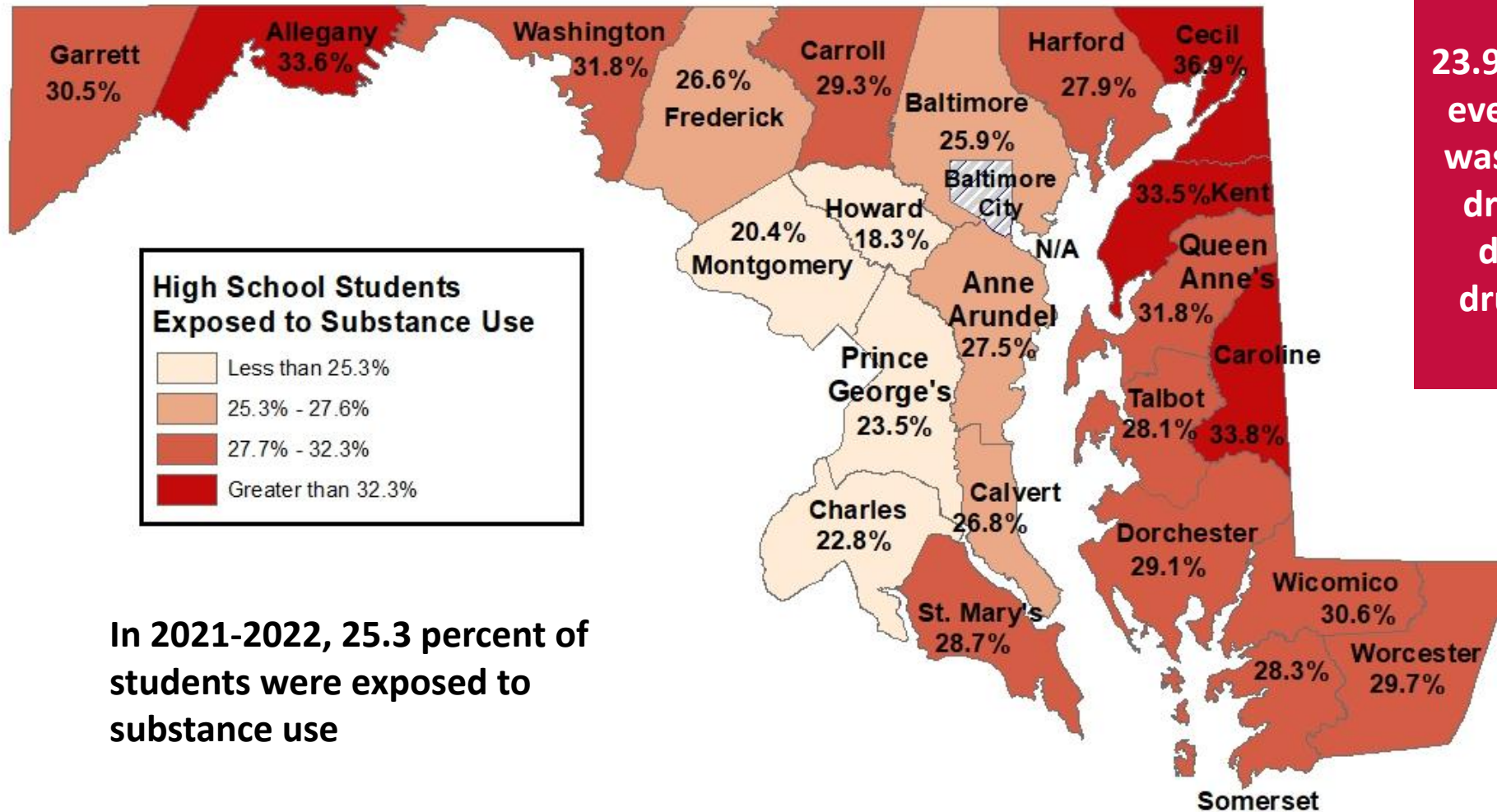
In 2021-2022, 12.1 percent of students exposed to emotional abuse

20.6 percent of students reported a parent or other adult in their home regularly swears at them, insults them, or puts them down.

Household Substance Use (MAP)

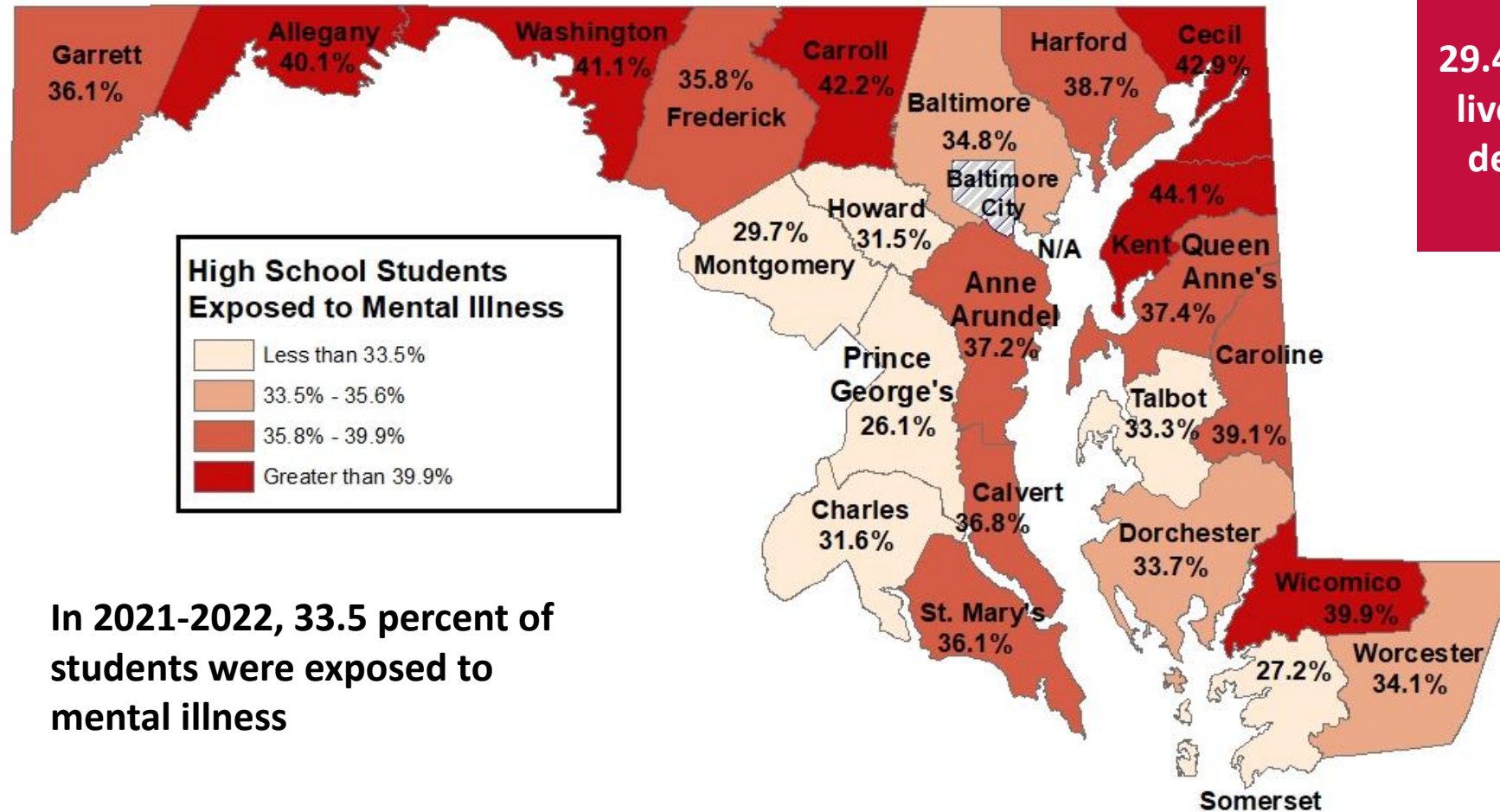


In 2021-2022, 25.3 percent of students were exposed to substance use

2018-2019
23.9 percent of students have ever lived with anyone who was an alcoholic or problem drinker, used illegal street drugs, took prescription drugs to get high, or was a problem gambler.

Household Mental Illness (MAP)

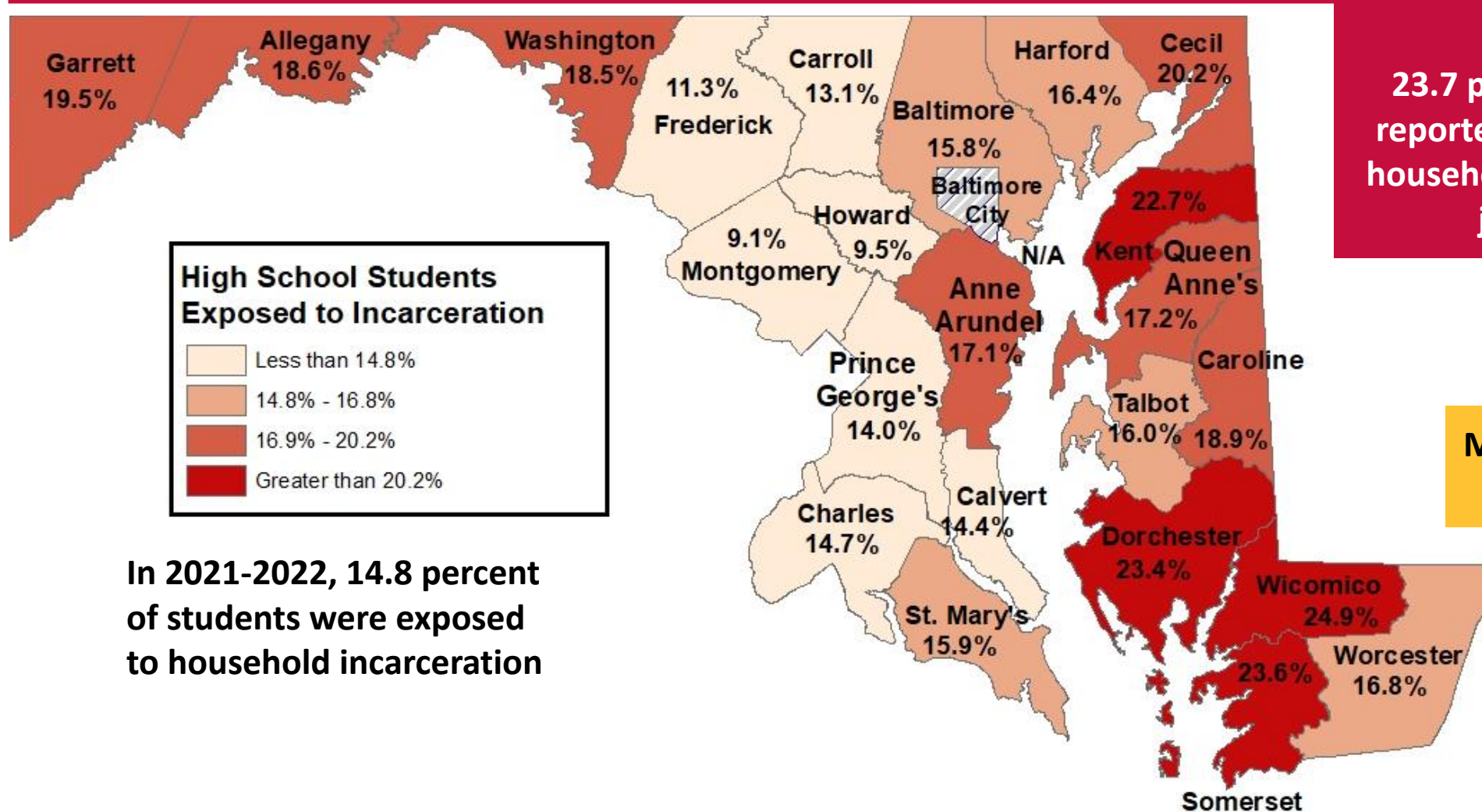

Household Incarceration (MAP)

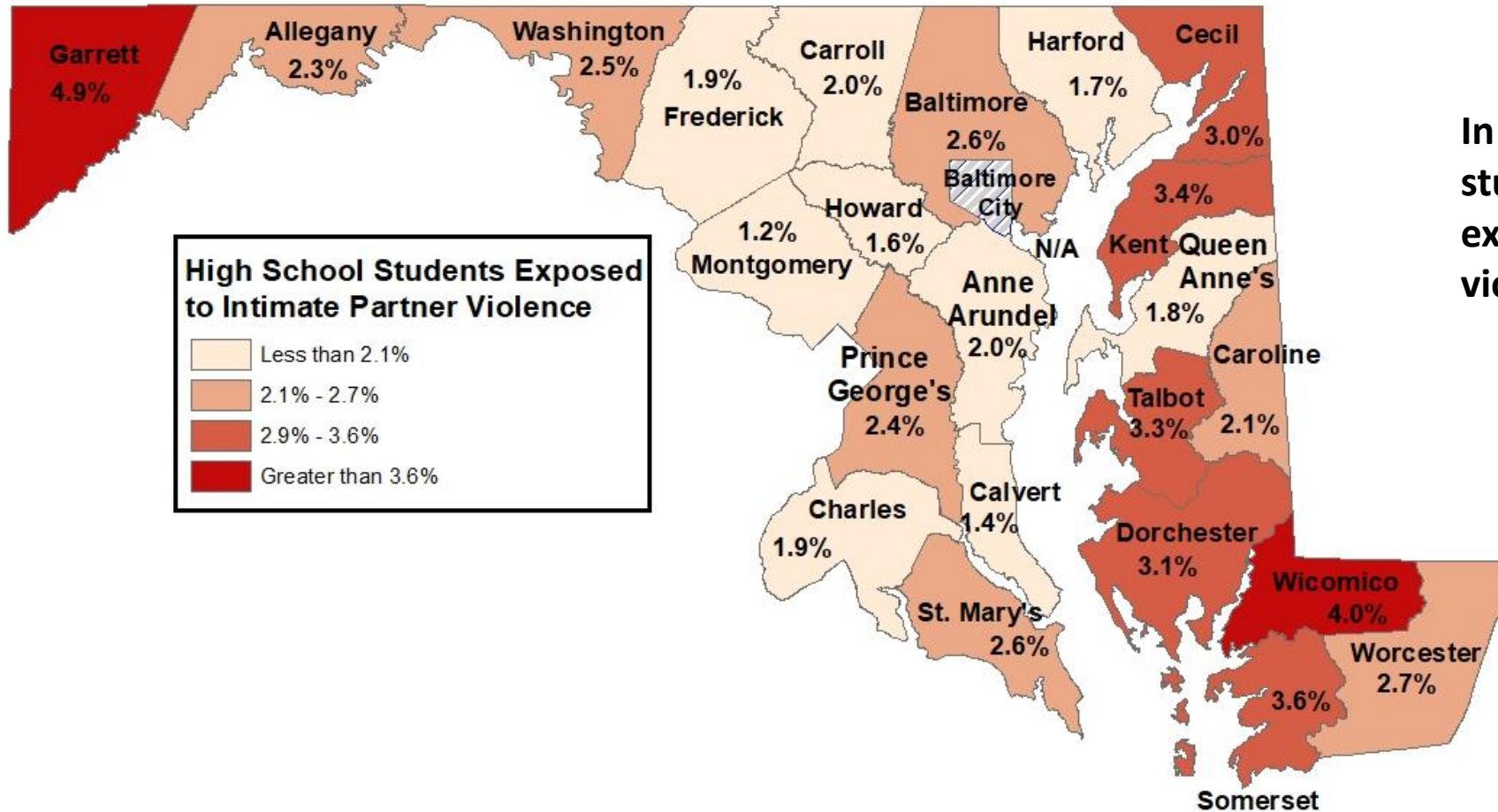


2018-2019

In 2021-2022, 14.8 percent of students were exposed to household incarceration

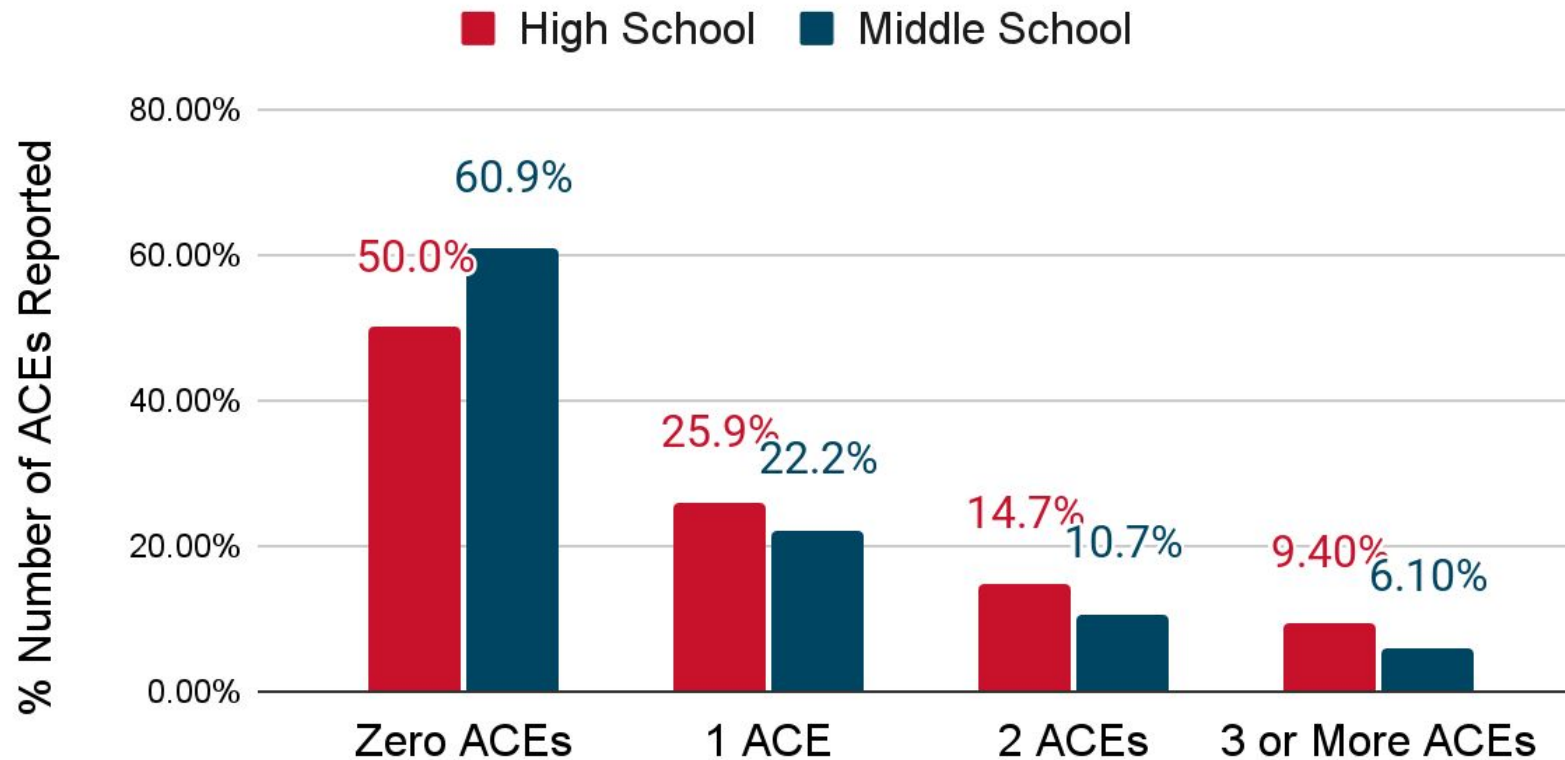
Witnessing Intimate Partner Violence (MAP)

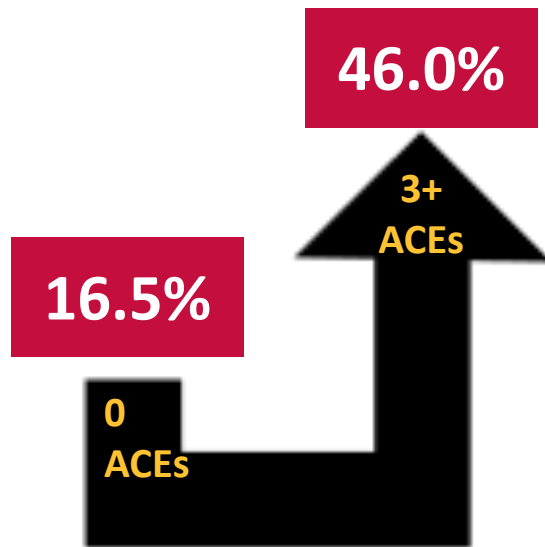

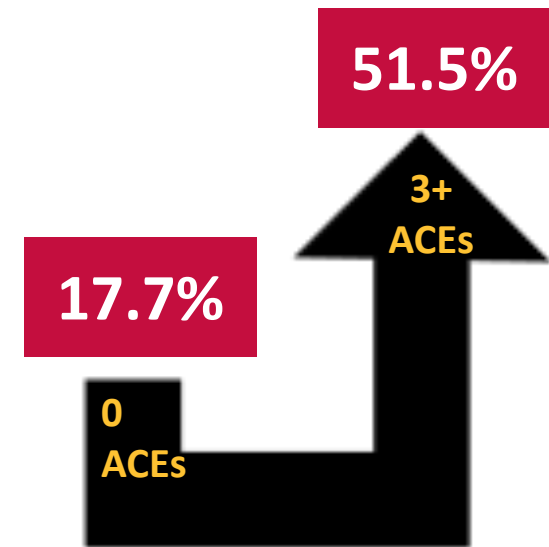

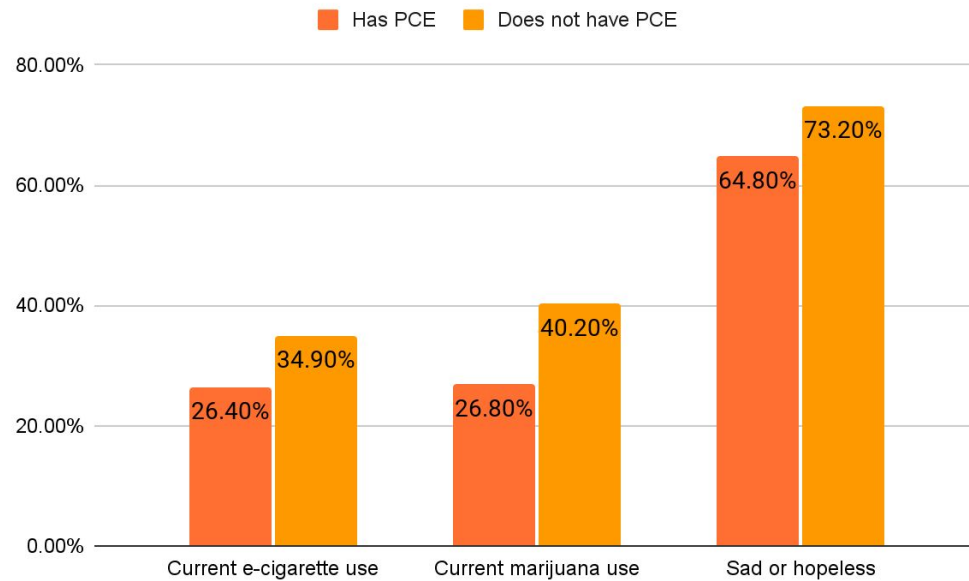

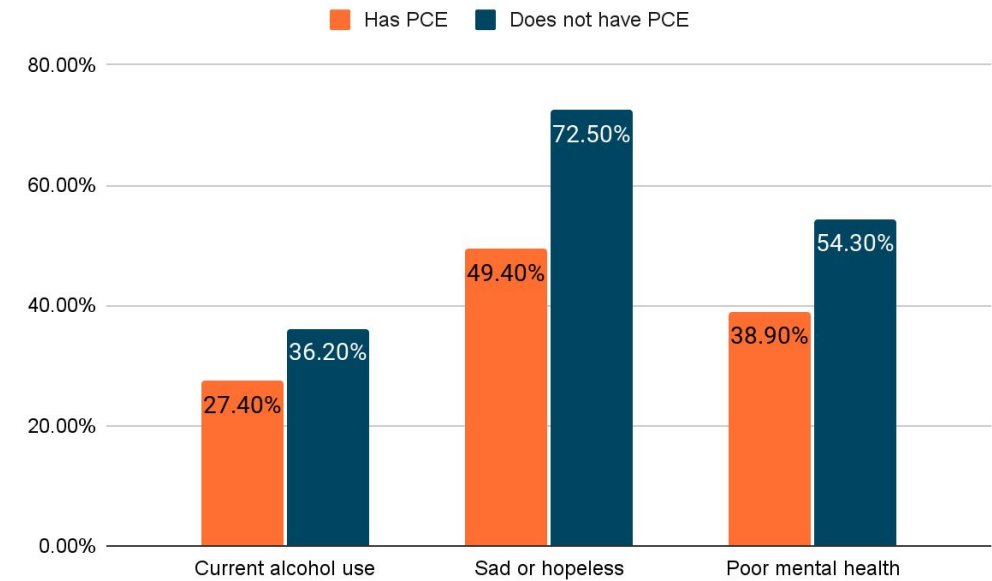
To mitigate the effects of ACEs communities can focus on strategies that promote positive childhood experiences which can lessen the effect of ACEs and reduce ACE exposure.

Participation in Extracurricular Activities

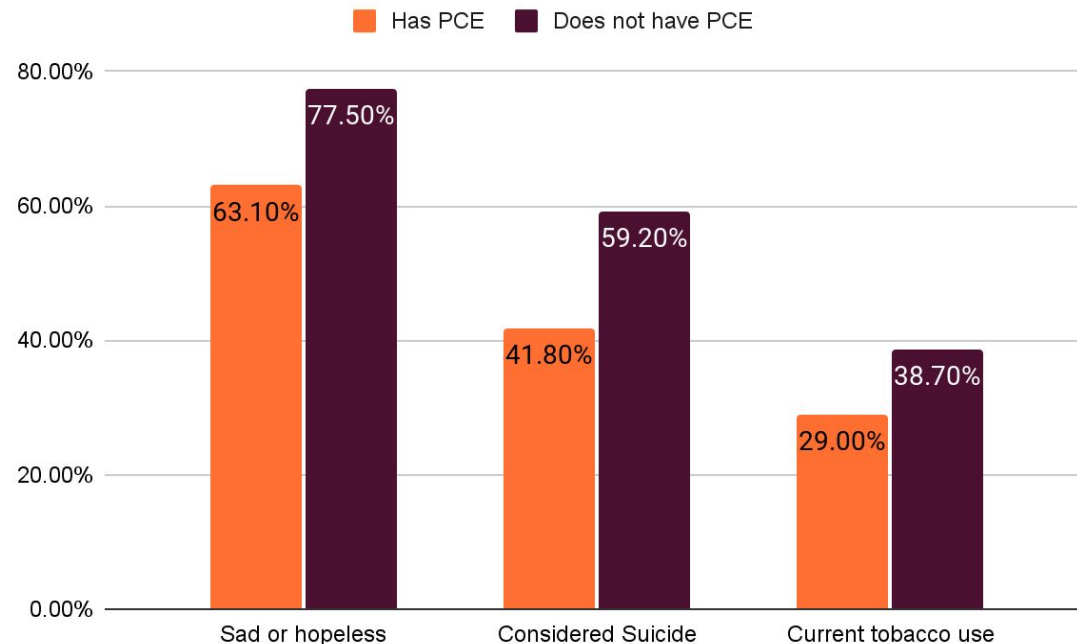


Able to Talk to an Adult about their Feelings

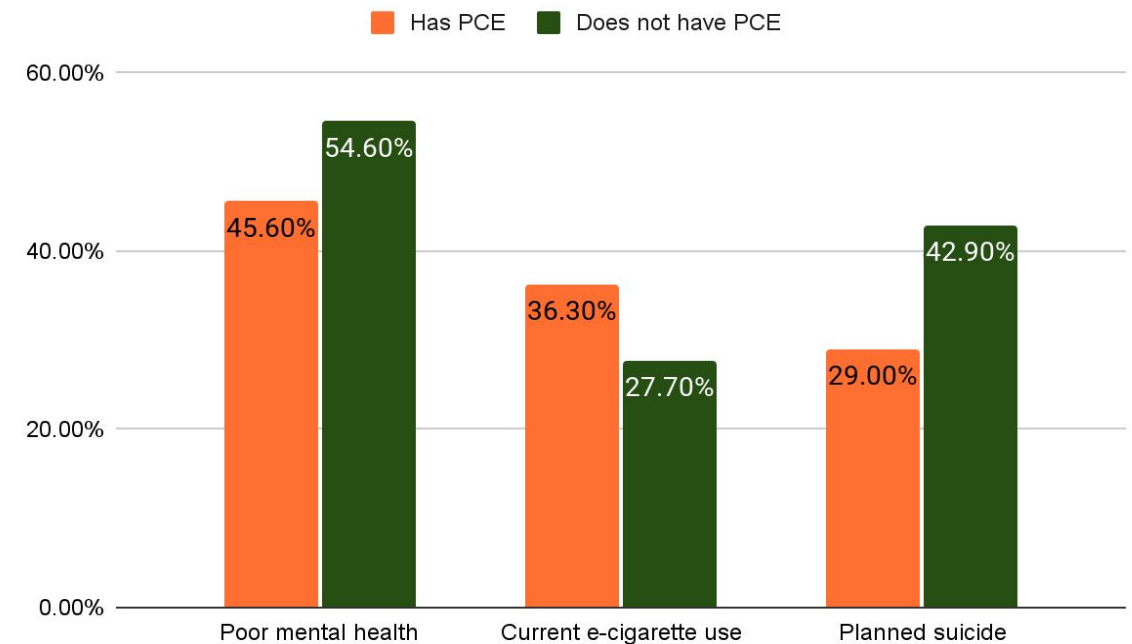


PCEs and Risk Behaviors - Among students with 3 or more ACEs (2)

Final Thoughts

In Summary

- Increases in poor mental health outcomes call for improved access to mental health support in school and at home and increasing positive childhood experiences through peer supports, school-based extracurricular activities, and adult support.
- As students return to school, we hope that there are programs in place to educate and re-emphasize the harms of substance use.
- The next YRBS/YTS data set (2022-2023) will be released early 2024 and will include the full 8 question ACEs module on the high school survey.
- The next YRBS/YTS administration is scheduled for Fall 2024.
