Frederick County Held Successful Drug Takeback Day

FREDERICK, MD -- On Saturday, April 27, the Frederick County Health Department (FCHD) partnered with the Frederick Police Department, Maryland State Police and the Drug Enforcement Agency (DEA) to host the “National Prescription Drug Take-Back Day.” From 10 a.m. to 2 p.m., 115 residents turned in over 250 pounds of unwanted or expired medication and over 16,000 sharps at two collection sites.

“We thank our Frederick County community for turning out in full force despite the rainy conditions to dispose of medications and syringes safely. Proper disposal of unwanted medication and sharps helps keep our community safe,” said Nate Smith, FCHD’s Opioid Misuse Prevention Program Coordinator. “We are incredibly grateful to our community partners who came out and gave part of their Saturday to make this event a success. A huge thank you to the Frederick City Police Department, Maryland State Police and the DEA for helping to staff the event.”
