2. Round Robin/Updates from Coalition Members

- Dawn Shugars (Liquor Board) – Alcohol merchant compliance checks are being conducted by the FCLB and are in full swing. MSP is conducting compliance checks on behalf of the FCHD and we are waiting for more details from MSP.
